1. Aim

Asistencias Técnicas de Ingeniería Consultores, S.L. (hereinafter ATI Consult) is committed to the integration of environmental aspects and energy efficiency in its day to day work, despite the fact that the nature of its activity is not particularly aggressive with the environment.

The management team of ATI Consult, aware of its commitment to its clients and the environment, has approved an Environmental Policy whereby the company guarantees the protection of and respect for the environment, ensuring continuous improvement of its environmental performance, focusing primarily on the identification and control of its environmental impacts.

ATI Consult considers environmental excellence as a core value of its corporate culture, so the environmental policy of ATI Consult represents the reference framework in which to establish the general principles of action.

Furthermore, it is the cornerstone of a system that responds to the expectations of the company's stakeholders regarding environmental conservation and the increasingly demanding regulatory requirements at a global level.

As stated in Goal 17 of the 2030 Agenda for Sustainable Development adopted by the United Nations, "A successful sustainable development agenda requires partnerships between governments, the private sector and civil society. These inclusive partnerships (...) that place people and the planet at the centre, are needed at the global, regional, national and local level". Therefore, ultimately, we must join forces to strengthen the Global Partnership for Sustainable Development.

2. Field of application

This Policy is applicable to the entire structure of the company and is supported by the General Management. All members of the ATI Consult team are responsible for promoting the principles and commitments contained in this document in the performance of their work.



3. General principles of action

The Environmental Policy of ATI Consult establishes the following basic principles:

1. RESPECT AND CARE FOR THE ENVIRONMENT:

Establishing an effective [Environmental Management System](#), which will be actively maintained and updated, working for continuous improvement through compliance with its requirements and expectations.

[Protecting the environment, preventing pollution and minimising the real](#) or potential impact on the environment, implementing a strategy to avoid any type of pollution that could result from the operations involved in our activity.

[Complying with the environmental legislation and regulations](#) applicable to the activity, and continuously monitoring its progress.

2. RESPONSIBLE AND SUSTAINABLE CONSUMPTION

Applying technologies, activities and processes to [minimise waste production and promote energy saving](#).

Ensuring the [appropriate treatment of the waste produced](#) by the activity, prioritising waste prevention, reduction, recycling and reuse over other types of treatment.

Making good use of drinking water, implementing measures that help us care for and save water, as its use is necessary in the performance of the company's activities in order to carry out its processes.

3. AWARENESS-RAISING

Promoting communication to the entire team of ATI Consult to raise awareness and encourage training in [care and respect for the environment](#).

[Involving and motivating](#) the different stakeholders in order to seek their participation in the management, development and application of the Environmental Management System..

[Proactively informing](#) about all decisions taken to respect and care for the environment.



4. COMMITMENTS

To carry out its activity in a [sustainable manner](#), following the life cycle approach and considering environmental criteria both in purchases and in new developments, as well as [mitigating its possible impact on climate change](#) by controlling and monitoring greenhouse gas emissions, minimising them whenever possible.

4. Update and revision

The Environmental Policy shall be revised and updated if necessary, to adapt it to any possible changes in the business model or field of action of ATI Consult or resulting from the approval of directly applicable regulations, ensuring the effectiveness of the policy and compliance therewith.

All of us at ATI Consult undertake to uphold these principles, and it is our responsibility to put them into practice. ATI Consult promotes environmental improvement, and allocates the necessary resources to ensure the successful implementation of this environmental policy.
